## **CHAPTER I**

### **SUPPLEMENTARY TRADE INSURANCE FACILITIES**

The principal facilities offered by E.C.A.'s are described in detail in the various chapters of this manual. However, most E.C.A.'s provide some ancillary or supplementary facilities depending on the nature and needs of their respective country's export trade and the interrelationship between the E.C.A. and the financial system in individual countries.

While no comprehensive summary of such facilities has been tabled, the attention of users of this manual is drawn to Section III, where reference to such facilities is made in the description of the Trade Insurance systems of nine different E.C.A.'s.

In addition, Appendix 1 contains an outline of all the facilities provided by seven E.C.A's in Developed Countries.
